- I. These guidelines are adopted to expand students' areas of learning, develop students' capability of integrating knowledge in different fields, and benefit from seeking advanced education and pursuit of careers.
- II. Academic units at NCHU such as colleges, departments, graduate institutes, degree programs, offices, centers, may jointly offer Interdisciplinary Credit Program courses as needed. Cross disciplinary programs for undergraduate students may offer their Micro Program as needed [or establish independent micro-credit programs](#).
- III. The title, content, and the chairman of a new Interdisciplinary Credit Program should be discussed and determined by the relative academic departments.
- IV. The Interdisciplinary Credit Program for graduate students must consist of a minimum of 9 credits.  
The Interdisciplinary Credit Program for undergraduate students must consist of a minimum of 12 credits; the Micro Credit Program under it [or independently established Micro Credit Programs](#) must consist of a minimum of 6 credits.  
The Interdisciplinary Credit Program shall be academically integrated. A minimum of 6 credits of the required courses must not be a part of the students' original major, double major, or minor required courses; A minimum of 4 credits in The Interdisciplinary Micro Credit Program must not be a part of the students' original major, double major, or minor required courses.
- V. Courses in different programs with the same title or those determined as equivalent courses by the department (degree program) can simultaneously fulfill the requirements of different programs; however, the credits shall only be accounted once in the credits for graduation.
- VI. Each program shall specify the targeted students, quota, standards, and other criteria.

Non-NCHU students must comply with related rules in NCHU's

- "Implementation Rules for Inter-University Courses Selection" or NCHU's "Regulations for Courses Opening for Auditing" to enroll in NCHU courses offered by the Interdisciplinary Credit Program.
- VII. If necessary, programs may charge credit fees or material costs to students taking the course.
  - VIII. The convener of newly established Interdisciplinary Credit programs shall present a minimum of 3 evaluations by relevant experts along with the implementation plan for review by the respective curriculum committees at various levels before the program can be offered.
  - IX. The name of the course subject (in both Chinese and English), purpose of the course, participating departments, name of the Chair, course plan, target students, teacher background, funding, tuition, and other details shall be included in the overall course blue-map. The detailed course plan shall include all subject names, credits, department that offers the classes, course outline and other details; the contents of the course shall be recognized and accepted by all participating units (department).
  - X. Students are not allowed to request for extension of study period due to participation in credit program courses. Students' grades in credit program courses and the regular undergraduate courses are averaged to produce the grade point average of the semester. As for graduate students, grades in credit program courses are averaged with regular graduate courses only when the credit program courses are related to the students' major field of study. If the credit program courses are not related to their field of study, the grades of the credit courses shall be excluded in the calculation of average grades.
  - XI. Students wishing to take the Interdisciplinary Credit Program shall fill out and submit an application within 3 weeks after the registration date for the stamped approval of the program convener and then to the Registration Division for approval and future reference.
  - XII. Students who already took certain courses in a credit program before registering may obtain credit exemption from the program convener in order to include those courses in the credit program record; there is no need to re-take the courses.
  - XIII. Students who fulfill the subject and credit requirements of a credit program shall complete and submit an application for their certificate of course attendance with their transcript. The program convener and Registration Division will issue the certificate of course attendance after verifying the application and transcript.

- XIV. The name, contents, and the means of implementation of inter-university cooperative course programs may be decided by way of agreements between NCHU and other universities. However, the course plan shall be passed by the Course Committee of NCHU.
- XV. Credit programs which have fewer than a cumulative of 10 students applying for study in every 3 school years five years following the establishment of said credit program shall be submitted to the University's Curriculum Committee to discuss whether the program be discontinued.
- XVI. These guidelines and any amendments hereto shall be implemented after being passed in the Academic Affairs Meeting.
