National Chung Hsing University Guidelines for the Implementation of the Post-Baccalaureate Multidisciplinary Specialization Program

Enacted in the 76th Academic Affairs Meeting on Oct. 31st, 2018 Amended (Article 11) in the 77th Academic Affairs Meeting on Mar. 27th, 2019

- Article 1 These guidelines are formulated in accordance with the Ministry of Education's "Regulations for Universities on Multidisciplinary Skills Training Programs".
- Article 2 The admission qualifications for application and admission to the Post-Baccalaureate Multidisciplinary Specialization Program (hereinafter referred to as "the Guidelines") are limited to individuals who have already obtained a bachelor's degree or higher. Applicants with academic credentials from abroad must comply with the requirements outlined in the Regulations Governing the Assessment and Recognition of Foreign Academic Records by Institutions of Higher Education, the Regulations Governing the Examination and Recognition of Educational Records from Hong Kong and Macao, and the Regulations for the Recognition of Academic Credentials from Mainland China, as established by the university.
- Article 3 This program is approved by the Ministry of Education. The study period for enrolled students must be at least one year and no more than four years. Applications for extensions, suspension, or transfer of department are not permitted.
- Article 4 This program follows the class schedule of the extension programs and is conducted in a concurrent enrollment format.
- Article 5 Students enrolled in this program are not required to take a minimum number of credits each semester. However, they must pay the necessary fees each semester as per the university's regulations. Students who fail to make the payment by the specified deadline will be expelled. The university will inform the student to complete the withdrawal process within a designated time frame.
- Article 6 If a student under this program voluntarily withdraws or is expelled and has completed at least one semester with recorded grades, they may be issued a certificate of attendance. Students approved for withdrawal must complete the necessary procedures; otherwise, the university will not issue a certificate of attendance.
- Article 7 After enrolling in this program, students must complete either the required graduation credits specified by their respective departments or a minimum of 48 credits in professional courses.

Students who have obtained certificates of professional course credits after graduating from university, in accordance with the Regulations for the Implementation of "Continuing Education in Colleges and Universities", the "Regulations for Vocational Continuing Education in Colleges and Universities", and the "Regulations for Vocational Continuing Education and Evaluation for Training Institutions", may apply for credit transfer/exemption in accordance with the university's "Credit Transfer Regulations". After the credit transfer/exemption, the actual number of credits earned through coursework must not be less than 12.

- Article 8 The tuition and fee standards for this program shall be handled in accordance with the regulations for the University's extension education undergraduate programs. Students are required to pay the credit fees after finalizing their course selection, and all payments must be made to the designated bank using the issued payment slip.
- Article 9 Students in this program who complete the required period of study, pass all assessments, and meet the graduation requirements will be awarded a bachelor's degree certificate in accordance with the Degree Conferral Act, with the notation "Post-Baccalaureate Multidisciplinary Specialization."
- Article 10 Matters not specified in these Guidelines shall be handled in accordance with the relevant university policies.
- Article 11 These Guidelines and any amendments hereto shall be approved in Academic Affairs Meetings before taking effect and are officially announced.
