Article 1 This Regulation is adopted pursuant to Article 26 of the University Law.

Article 2 Students from each department (degree program) [who meet one of the following conditions](#) may apply for early graduation in the semester or academic year prior to the completion of their study period after completing all credits required by the department (degree program) for graduation.

[1. Students with outstanding academic performances:](#) Overall GPA for all semesters enrolled (excluding the final semester prior to graduation) shall remain above 80 or academic grades for each semester rank among the top ten percentile of the class in the department/degree program [and](#) conduct grades remain above 85 (excluding the final semester prior to graduation).

[2. Male conscripts born after 2005 who apply for flexible military services in undergraduate programs.](#)

Transferred students enrolled as junior or students promoted to a higher grade (junior or above) after admission shall not apply for early graduation.

Article 3 Students who apply for early graduation shall fill out the “Application Form for Early Graduation” [during the 11th and 12th weeks in the academic calendar](#), along with the approval of Head of the department (degree program) and send it to the Registration Division of the Office of Academic Affairs for review. [Students with outstanding academic performances](#) shall be marked as Students with Outstanding Achievement for Early Graduation in the Booklet of Graduates List in compliance with the “Guidelines for Graduation Requirements”.

Article 4 This Regulation and any amendments hereto shall be announced and implemented after being passed in the school's Academic Affairs Meeting and submitted to the Ministry of Education for future reference.
