

# NCHU Regulations for Distinguished Speakers

**Article 1** The NCHU Regulations for Distinguished Speakers (hereinafter referred to as Regulations) have been established to enhance NCHU's academic competency and facilitate a learning environment.

**Article 2** Lectures by distinguished speakers are separated into two categories: Hui-Sun lectures and general education lectures. Funding for these lectures has been earmarked by NCHU.

**Article 3** The Hui-Sun Lectures Review Committee shall consist of the President, one Vice President, the Vice President for Academic Affairs, the Vice President for Student Affairs, the Vice President for General Affairs, the Vice President for Research and Development, the Vice President for International Affairs, Deans of colleges, and President of the NCHU Student Government. The President shall serve as chair of the committee.

The Center for General Education shall regularly review Hui-Sun Lectures applications and provide applicants with related information that will be required by the Committee for documentary review.

**Article 4** Speakers invited to speak at Hui-Sun Lectures shall meet at least one of the following criteria:

- I . Heads or deputy heads of states.
- II . Government officials that are ranked ministers or higher.
- III . Major global religious leaders.
- IV . Nobel Prize winners or recipients of other awards of international renown.
- V . Fellows at the Academia Sinica or the equivalent from other states.
- VI . Leaders or high-ranking officers at major corporations.
- VII . Presidents at renowned universities.
- VIII . Leading authorities in various fields with outstanding contributions.
- IX .Other distinguished speakers that are on par with those listed hereinabove.

**Article 5** NCHU will host a maximum of 10 Hui-Sun Lectures each year or until the earmarked funds are exhausted. Distinguished speakers will receive

NT\$30,000 and a commemorative plaque as compensation. The total budget for each Hui-Sun Lectures shall not exceed NT\$50,000.

Article 6 The Center for General Education is responsible for reviewing the qualifications of General Education Lecture speakers and submitting it to the Vice President for Academic Affairs for approval. Each speaker will be compensated NT\$10,000 or less, the total budget for each General Education Lecture shall not exceed NT\$20,000.

Article 7 Distinguished speakers shall, in principle, be invited only once every two years; however, this shall not apply to the University's Contract Chair Professors.

Article 8 These Regulations and any amendments hereto shall be approved in administrative meeting before taking effect.
